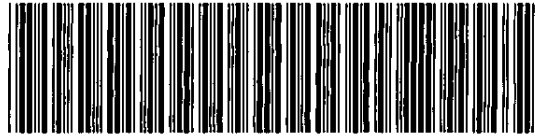

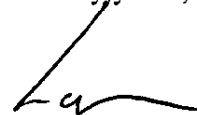

NAME
