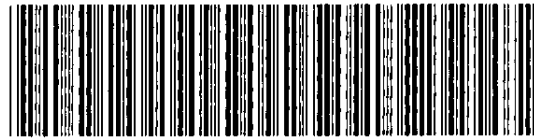

I, the undersigned, do hereby make form a corporation, and for such purpose I hereby make, execute and adopt the following Articles of Incorporation.

**ARTICLE ONE  
NAME OF CORPORATION AND ADDRESS OF PRINCIPAL OFFICE**

The name of this corporation shall be: FIRST IMPRESSIONS EXTERIOR SERVICES, INC., a Florida corporation. The address of the principal office of the corporation is 4803 Rayford Street, Jacksonville, Florida 32254.

**ARTICLE TWO  
PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

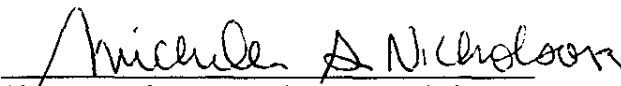

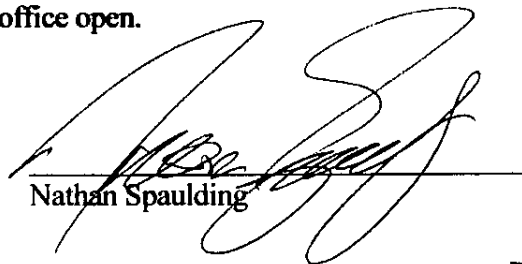
