ARTICLES OF INCORPORATION

OF

ORB MUZIK CORP.

We hereby associate to form a stock corporation under the provisions of Chapter 607 of the laws of the State of Florida and to that end set forth the following:

ARTICLE I: NAME OF CORPORATION

The name of the corporation is: ORB Muzik Corp.

ARTICLE II: PURPOSES OF THE CORPORATION

The purpose for which the corporation is organized is to engage in any or all lawful business for which corporation may be incorporated under Florida's statutory corporation law or under any act amendatory thereof supplemental there to or in substitution therefore.

ARTICLE III: CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is ONE Thousand (1000), to consist of ONE (1) class only, the par value of such shares to be at ONE DOLLAR (\$1.00) per share. All of said stocks shall be payable in cash, property, real or personal, or labor or services in lieu of cash, at a just valuation, to be fixed by the board of Directors of this corporation. The payment does not have to be at the time of issuance, provided that said shares are subject to calls thereon until the whole consideration therefore shall have been paid.

ARTICLE IV: DURATION OF THE CORPORATION

The duration of this corporation shall be perpetual sooner dissolved according to law.


ARTICLE IX: BYLAWS
