ARTICLE I - NAME

The name of this corporation is CONTRACT SERVICES INTERNATIONAL, INC.

ARTICLE II - PRINCIPAL OFFICE

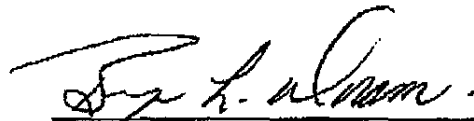
