

## Existence

The corporation's existence shall commence on June 2, 2008.

### ARTICLE III

## **Nature of Corporate Business and Powers**

The general nature of the business to be transacted by this Corporation shall be:

A. To engage in every aspect and phase of the Business of the sale of fish and all related services authorized to render.

### **CONFLICT OF INTEREST**


