ARTICLE I

NAME

The name of this corporation is MDC INTERNATIONAL INVESTORS INC.

Expenses (including attorneys' fees) incurred in defending any claim action, suit or proceeding may be paid by the corporation in advance of the final disposition of such a proceeding.


