The undersigned, acting as incorporators of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: UNITED SECURING 1, INC., a Florida for-profit corporation. The principal place of business of this corporation shall be 87 Campbell Street, LaBelle, 33935.

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The corporation is organized to provide property preservation and maintenance to the general public for a profit.

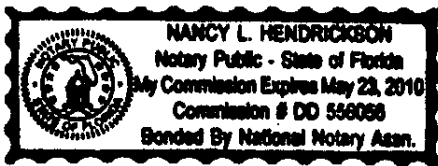


