

ARTICLE I - NAME

The name of the corporation is Renata's Hair Fashion, Inc., at 340 4th Avenue, Indiatlantic, FL 32903 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
