

ARTICLES OF INCORPORATION Of

VAN RENSBURG AVIATION, INC.



ARTICLE I - Name

The name of the corporation shall be: VAN RENSBURG AVIATION, INC.

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: AIRCRAFT OWNERSHIP,

PURCHASING OF PARTS and related operations.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Thousand (I000) shares of Ten Cents (.10) par value common stock which shall be designated "Common Shares."

ARTICLE V - Preemptive Rights
