

## **ARTICLES OF INCORPORATION**

**OF**

### **ARTICLE I - NAME**

The name of this corporation is BEN GREENWOOD, INC.

### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### **ARTICLE VIII – OFFICERS**






