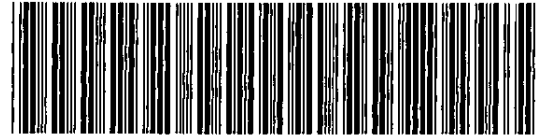

1. Management.
