

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF APEX AUTO, INC.

Pursuant to the provisions of Section 607.1006 of the Floridae Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Office of Incorporation:

Article I - Name

The name of the corporation is APEX AUTO, INC., (hereinafter referred to as the "Corporation").

Article II - Adoption and Text of Amendments
