The undersigned do hereby associate themselves for the purpose of forming a corporation under the laws of the State of Florida under the corporate name NORTH FM SLICK ROCK PROPERTIES, INC. and hereby set forth and declare:

# CHARTER

## Article I

The name of the corporation shall be 16991 Laurelin Court, City of North Fort Myers, County of Lee, in the State of Florida.

## Article II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

## Article III
