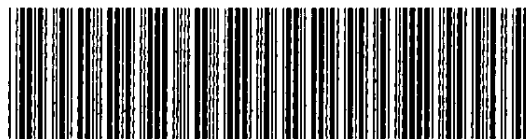

**ARTICLES OF INCORPORATION  
OF  
AVOCADO CAFE N' BAKERY, INC.**

**ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS**

The name of the Corporation shall be **AVOCADO CAFE N' BAKERY, INC.** The principal and mailing address of the corporation shall be 14941 Bruce B. Downs Blvd., Tampa, Florida 33613.

**ARTICLE II - CAPITAL STOCK**


