**ARTICLES OF AMENDMENT
TO THE
THE ARTICLES OF INCORPORATION
OF**

SOUTH FLORIDA PAIN & REHABILITATION CENTER CORP.

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, SOUTH FLORIDA PAIN & REHABILITATION CENTER CORP., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is SOUTH FLORIDA PAIN & REHABILITATION CENTER CORP., (hereinafter called the "Corporation").
2. Article 5 of the Corporation's Articles of Incorporation is deleted and replaced by the new Article 5 as follows;

ARTICLE 5 - OFFICERS

The officer of the Corporation shall be:

President: Daniel Feder
Secretary: Daniel Feder
Treasurer: Daniel Feder

DANIEL FEDER shall serve as officer in the positions described above until successor officers are elected in his place and stead at a duly called meeting of the directors.

3. Article 6 of the Corporation's Articles of Incorporation is deleted and replaced by the new Article 6, as follows:

ARTICLE 6 - DIRECTOR(S)

The Director of the corporation is DANIEL FEDER, who shall serve until a successor director or directors are elected in his place and stead at a duly called meeting of the shareholders.

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

5. The amendment made herein to the Articles of Incorporation of the Corporation was adopted by the unanimous written consent of the Shareholders, the number of votes cast for the amendment was sufficient for approval, and the Directors of the Corporation on the date of these Articles of Amendment, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.


