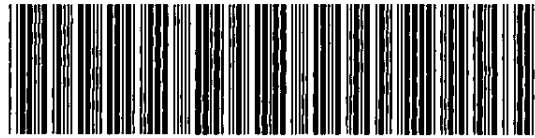

ARTICLE I - NAME

The name of the Corporation shall be David A. Geller, P.A. (the "Corporation").

ARTICLE II - ADDRESS

The mailing address of the Corporation is 15500 New Barn Road, Suite 104, Miami Lakes, Florida 33014.

ARTICLE III - PURPOSE

This Corporation is organized for the specific purpose of operating as a law firm and engaging in the practice of law, by and through the Corporation's officers, employees and agents, as those terms are used in Section 621.06 (or successor legislation). Florida Statutes, who are duly licensed or otherwise legally authorized to practice law in the State of Florida, and for the transaction of any and all other lawful business that the Firm may engage in under Chapters 621 and / or 607, Florida Statutes, as may be amended from time to time.

ARTICLE IV - CAPITAL STOCK

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 15500 New Barn Road, Suite 104, Miami Lakes, Florida 33014, and the name of the initial registered agent of this Corporation at that address is David A. Geller.

ARTICLE VII – BOARD OF DIRECTORS

This Corporation shall have one (1) director. The number of directors may be increased from time to time by the By-Laws but shall never be less than one (1). The name and address of the initial director of this Corporation is as follows:
