Article 1 - Name

This right may also be waived by a written waiver signed by the shareholder.

The indemnification provided herein shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs, executors and administrators of such a person, and an adjudication of liability shall not affect the right to indemnification for those indemnified.


Article 12 - Amendment
