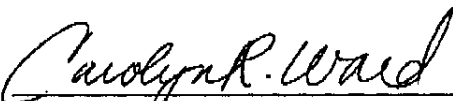
The date for commencement of this corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Department of State.
