ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 **Name.** The name of the corporation is AMS CAPITAL ADVISORS, INC. (the "Corporation").

Section 1.2 **Address of Principal Office.** The address of the principal office of the Corporation is 13742 Bermuda Cay Court, Jacksonville, Florida 32225.

ARTICLE II

DURATION

Section 2.1 **Duration.** This Corporation shall exist perpetually. 
**ARTICLE IX
