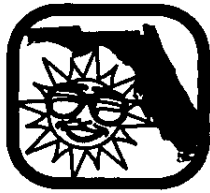

THE UNDERSIGNED, ACTING AS INCORPORATOR OF A PROFESSIONAL ASSOCIATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF ASSOCIATION:

FIRST: The name of the professional association is Eilis Clark MD, PA.
