ARTICLE I - NAME AND ADDRESS: The name of this professional service corporation shall be RICHARD L. DOODY, ESQ., P.A., with its principal address and mailing address being 800 East Broward Boulevard, Suite 710, Fort Lauderdale, FL 33301.


