CERTIFICATE OF INCORPORATION

OF

The undersigned hereby associate us together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formution, rights privileges immunities and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the State of Florida and the United States of America.
