


As we discussed today, I am enclosing a check for \$78.75 to cover the filing costs and certificate of status for incorporation of the above company.


I am the President of LF of America, LLC and have been employed here since its inception in 2002. Initially, the Florida limited liability corporation (Document #L02000010895, EIN 04-3657912) had two (2) partners, Lameplast SPA, a foreign corporation, and World Pharmaceuticals Inc, a Florida corporation.

On February 29<sup>th</sup>, 2008, World Pharmaceutical Management, Inc. sold its 45% interest to Lameplast SPA, the remaining partner. Under federal tax law, the partnership ceased to exist with only one partner. To resolve this issue, Lameplast SPA requested that a new Florida corporation be formed, LF of America Corp. We attempted to incorporate LF of America Corp online, but the application was rejected because of the similarity of names between the old LLC (LF of America, LLC) and the new corporation (LF of America Corp.).

Lameplast SPA, a foreign corporation, was the majority partner of the old LLC, LF of America LLC, and will be the 100% owner of the new corporation, LF of America Corp. Lameplast SPA wants the similarity in names because of its investment in promoting the name LF of America in the marketplace.






