ART (CLES OF INCORPORATION (PROFIT)

Gilberto Gomez, being of the age of eighteen (18) years old or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

- 1. The name of the Corporation shall be: CHICHO GOMEZ CONSTRUCTION, INC.
- 2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$1.00 per value.
- 3. The street address and county of the initial principal office of the corporation is: 18550 SW 265 St. Homestead, Fl 33031 -Miami-Dade County and the name of the initial register agent at this address is: Gilberto Gomez at the same address.
- 4. The number of the directors constituting the initial Board of Directors shall be one director and the name and address of the person whom is to serve as director until the first meeting of shareholders or until their successors are elected and qualified are:
