The undersigned does hereby act as Incorporator in adopting the following Articles of Incorporation:

FIRST. The name of the corporation (hereinafter called the "corporation") is Mark D. Snider, P.A.

SECOND. The street address and mailing address of the initial principal office of the corporation is 2799 NW 28th Street, Boca Raton, Florida 33434.

THIRD. The purpose of the corporation is to engage in every phase and aspect of the business of rendering professional legal services and any other lawful business, act or activity that may be engaged in by a professional corporation formed for such purpose pursuant to the Professional Services Corporation and Limited Liability Company Act. The corporation shall have all of the powers granted or allowed to professional corporations pursuant to the Professional Services Corporation and Limited Liability Company Act, including all powers of a Florida corporation pursuant to the Florida Business Corporation Act and nothing herein is intended or shall be construed as limiting or eliminating any such powers.

FOURTH. The total number of shares that the corporation is authorized to issue is One Thousand (1,000) shares of Common Stock, \$.01 par value per share.
