ARTICLE I - Name

The name of the corporation is COPANS PARK, INC. (the "Corporation").

ARTICLE II - Purpose

The Corporation is organized for the sole purposes acting as General Partner for Copans Industrial Park, Ltd., a Florida limited partnership.

The Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent permitted by law in existence either now or hereafter.


ARTICLE IX - Fiscal Year



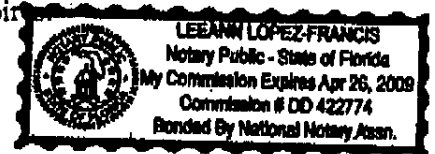
