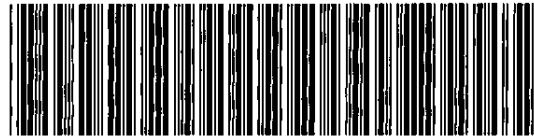


ARTICLE IX **INDENMIFICATION**

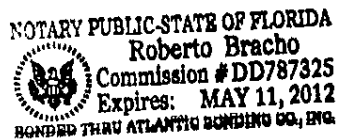
