

## JOINT ACTION BY WRITTEN CONSENT OF THE STOCKHOLDERS AND DIRECTORS OF

The undersigned, constituting the sole owner of the issued and outstanding capital stock of the corporation, and the sole stockholder of the Board of Director of **A BRIDE'S**NATURE, CORP., a corporation organized and existing under the laws of the Sate of Florida, does hereby take the following action by unanimous written consent, pursuant to the provisions of Section 608.441, Florida Status:
