
#### **ARTICLE XVII. SHAREHOLDERS' RESTRICTIVE AGREEMENT**

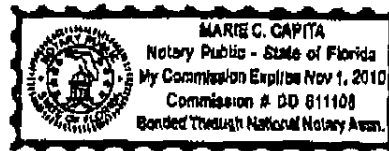
