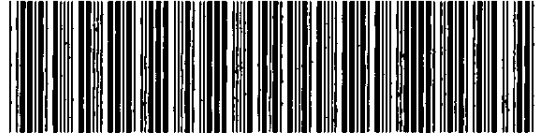

ARTICLES OF INCORPORATION
Of
THE LAW OFFICE OF EDWARD A. DIMAYUGA, P.A.

ARTICLE I

The name of the corporation shall be The Law Office of Edward A. Dimayuga, P.A.

ARTICLE II

The street address of the principal office of the Corporation is 1638 Almond Avenue, Orlando, FL 32814.

ARTICLE VII

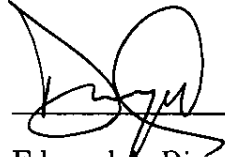

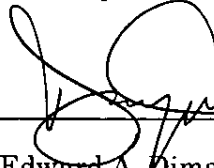
