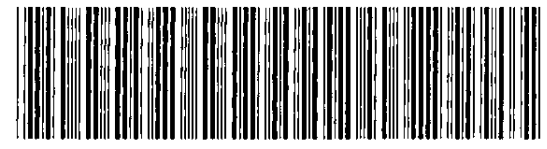

AMENDMENT


