ARTICLES OF INCORPORATION
For

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Value of Insight Consulting, Inc. Principal place of business is 2522 Center Avenue, Fort Lauderdale, FL 33305.

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
