**ARTICLES OF INCORPORATION
OF
LANCE BLOCK, PROFESSIONAL ASSOCIATION**

Article I. Name

The name of this professional service corporation is Lance Block, Professional Association.

Article II. Initial Principal and Registered Office and Agent

The street address of the initial principal office of this professional service corporation and the street address of the initial registered office of this professional service corporation is 3010 Thomasville Road, Tallahassee, Florida 32308. The mailing address of this professional service corporation is Post Office Box 840, Tallahassee, Florida 32302-0840. The initial registered agent at the initial registered office of this professional service corporation is Lawrence J. Block, Jr.

Article III. Purpose

This professional service corporation is formed to engage in every phase and aspect of the practice of law and any lawful act or activity for which a professional service corporation engaged in the practice of law may be organized under the Professional Service Corporation and Limited Liability Company Act and in which such a corporation is permitted to engage under other applicable law. This professional service corporation also may invest the funds of this professional service corporation in real property, mortgages, stocks, bonds and any other type of investment, and may own or lease real property and personal property necessary for the rendering of professional services.

Article IV. Capital Stock

This professional service corporation is authorized to issue 10,000 shares of \$1.00 per share par value common stock. None of the capital stock of this professional service corporation may be issued, sold or transferred to anyone other than to an individual duly licensed to practice law in the State of Florida or as may otherwise be legally authorized in Sections 621.09(1) and 621.11(11) of the Florida Statutes.

Article V. Preemptive Rights

Upon the sale for cash of any new stock of this professional service corporation of the same kind, class or series as that which he or she already holds, every shareholder shall have the

right to purchase his or her *pro rata* share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


Article VI. Management of Corporation by Shareholders


