**ARTICLES OF INCORPORATION
OF
ASSOCIATES IN INTERNAL MEDICINE, P.A.**

The undersigned, as incorporator, forms a Professional Service Corporation within the meaning of Florida Statutes, Chapter 621, and the applicable provisions of Florida Statutes, Chapter 607.

ARTICLE I - NAME

The name of the corporation is Associates In Internal Medicine, P.A. (the "Corporation")

ARTICLE II - ADDRESS

The address of the principal office address and mailing address of the Corporation is 277 Moses Creek Boulevard, St. Augustine, Florida 32086.

ARTICLE III - PURPOSE

The Corporation is organized, and shall be operated, to render "professional services" within the meaning of Florida Statutes, Chapter 621, in the practice of medicine and each of its sub-specialties as carried on by persons licensed in, or otherwise legally authorized to engage in, such practice in this State.

The Corporation shall render its professional services only through its officers, agents and employees who are duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of common stock, all of which shall be of the par value of \$1.00 per share.


