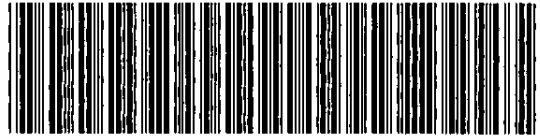


- 1.. The name of the corporation is: AWARE BEAR, INC.
