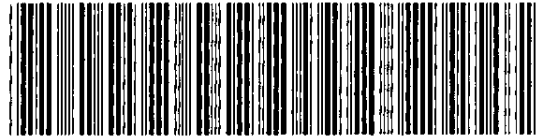

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Seamless Gutters-Sta-Dri Roofing, Inc.

ARTICLE II - PRINCIPAL OFFICE
