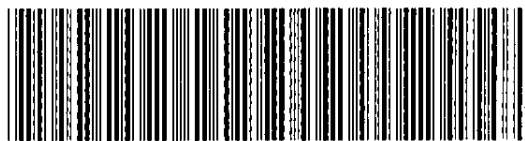

ARTICLE IX

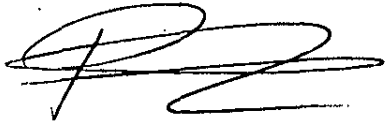
CUMULATIVE VOTING:
