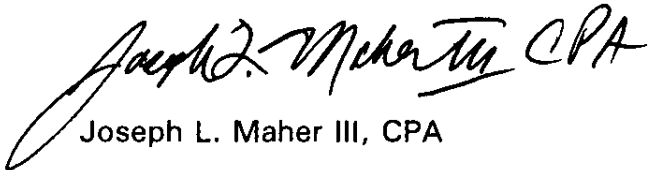

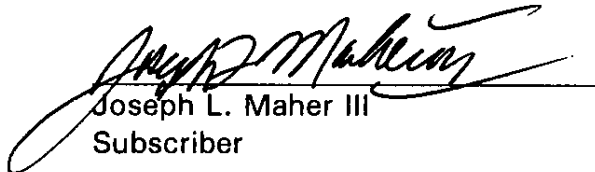
ARTICLE X - IDEMNIFICATION
