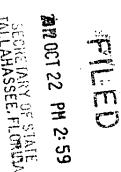

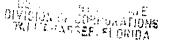

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, TONER PARTS EXPRESS, INC., a Florida corporation (the "Corporation"), adopts the following Amended and Restated Articles of Incorporation:

- 1. Name of Corporation. The name of the Corporation is TONER PARTS EXPRESS, INC.
- 2. <u>Text of Amendment</u>. The following Amended and Restated Articles of Incorporation was recommended by the written consent of the directors of the Corporation, and approved and adopted by the written consent of all of the shareholders of the Corporation, all in compliance with the Articles of Incorporation and Bylaws of the Corporation and the provisions of Section 607.1003 of the Florida Business Corporation Act, which amends and restates in its entirety the Articles of Incorporation of TONER PARTS EXPRESS, INC. as follows:

ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of the corporation is SOLUTIONS EMPIRE INCORPORATED

ARTICLE II. ADDRESS

The mailing address of the corporation is 4300 Northwest 120th Avenue, Coral Springs, Florida 33065.

ARTICLE III. COMMENCEMENT OF EXISTENCE
