AMENDMENT



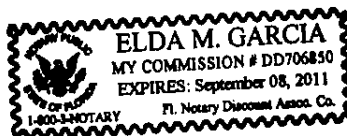
