ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is Ingrid Kenna PTA, Inc., at 4079 Timber Trail Court, West Melbourne, FL 32904 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE
