**ARTICLE I - NAME**

In accordance with §607.0401(1), Fla.Stat. (2003), the name of the Corporation is: NATIONAL UTILITY CONSULTANTS, INC.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the date of filing of these Articles, pursuant to §607.0203(1), (2), Fla.Stat. (1989).

**ARTICLE III - PURPOSE**

This Corporation is organized for the purpose of transaction of any and all lawful business in the State of Florida, pursuant to §607.0202(2)(b)1, Fla.Stat. (1993).

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue one hundred (100) shares of One (\$1.00) Dollar par value common stock, pursuant to §607.0601(1), Fla.Stat. (1993).

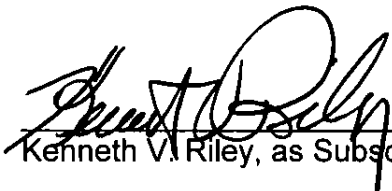

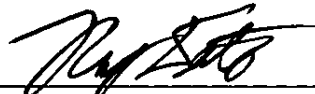
