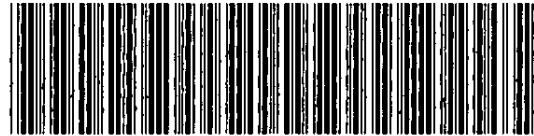

The undersigned, for the purpose of forming a for-profit corporation under the law of the State of Florida, do hereby adopt the following Article of Incorporation.

Article I
Name

The name of the corporation shall be **Bullard's Educational Technology Training Center, Inc.** (hereinafter called the "Corporation")

Article II
PRICIPAL OFFICE AND MAILING ADDRESS
