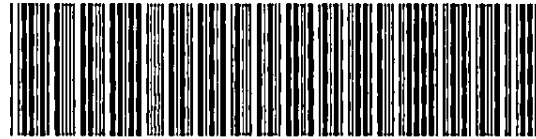

Mandaloun Inc., effective immediately, is owned by:


Pierre Barakat-Diab's shares consist of 50% of the business, and
