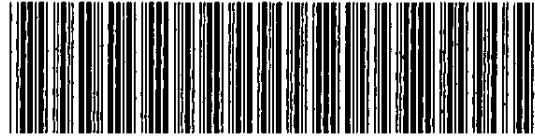

The undersigned incorporator, Fred Strouse, hereby forms All Troy Air Control, Inc., a corporation under Chapter 607 of the laws of the State of Florida.
