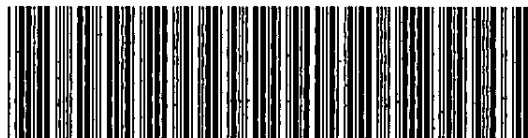

ARTICLES OF INCORPORATION

OF

ARTICLE I

Effective Date

The name of this corporation is: **Chris D. Kelly, P.A.**

ARTICLE II

The term of existence of the corporation is perpetual. The effective date of this corporation is July 1, 2008.

ARTICLE III

This corporation is organized for the following purposes:

A. To engage in public accounting as a professional corporation and to carry on services incident thereto. The practice of public accounting is the sole and exclusive professional service to be rendered by this corporation.

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom is duly authorized by law in the State of Florida.

D. Any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED

OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2101 North 9th Avenue, Pensacola, Florida 32503, and the name of the initial registered agent of this corporation at that address is **Chris D. Kelly**. The principal office is the same as the registered office.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one director, initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than one. The name and address of the initial director of this corporation is:


ARTICLE IX - BYLAWS


