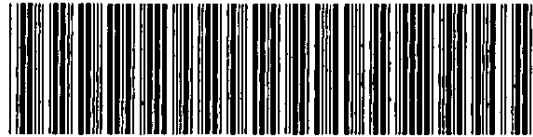

NAME


