The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be **Pulse Music Group, Inc.**

ARTICLE III. DURATION

The duration of the Corporation shall be perpetual.
