OF

Article I

Name. The name of this Corporation is Headhunter Health Exchange, Inc.

Article II

Principal Office. The address of the principal office of the Corporation is 5443 Southwest 91st Terrace, Gainesville, Florida 32608.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date these articles are filed with the Secretary of State.

Article IV

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including, but not limiting the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

Article V

Capital Stock. This Corporation is authorized to issue 1,000,000 shares of no par value common stock.






