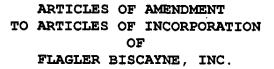

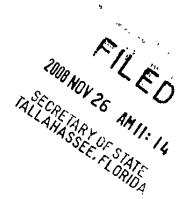

- **4.** The number of shares voted in favor of such Amendment was five hundred (500)), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon filing with the Department of State of Florida.
